

**EXHIBIT A
TO
QUITCLAIM DEED
(CATLIN GABEL AND COLTRANE)**

Legal Description

The South half of the Southwest quarter of the Southeast quarter, and the South half of the South half of the Southeast quarter of the Southeast quarter in Section 30, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, together with and subject to a 60-foot wide easement for road and utility purposes over the following described centerline: Beginning at a point on the East line of the County Road 30 feet North of the South line of the Southeast quarter of the Southwest quarter of Section 30, Township 2 North, Range 5 East of the Willamette Meridian, thence East parallel with the South line of said Section 220 feet; thence in a Northeasterly direction following the terrain to the center line of a creek at a point not more than 250 feet North of the South line of said Section; thence continuing in a Southeasterly and Easterly direction following the center of an old logging road to a point on the East line of the Southeast quarter of the Southwest quarter of said Section 30 which is 50 feet North of the Southeast corner thereof.
