10 PROTECT THE SECURITY HEREOF, GRANTOR(S) COVENANTS AND AGREES: (1) To keep said premises insured against fire, up to the full value of all improvements for the protection of Beneficiary; and that loss proceeds (less expenses of collection) shall, at Beneficiary's option, be applied on said indebtedness, if due, or to the restoration of said improvements. In the event of foreclosure, all rights of the Orantor in insurance policies then in force shall past to the purchaser at the foreclosure sale.
