## LEGAL DESCRIPTION

### PARCEL I

That portion of the Southeast quarter of the Southeast quarter of Section 28, Township 2 North, Range 8 East of the Willamette Meridian in the County of Skamania and State of Washington, described as follows:

Beginning at a point 543 feet North and 311.5 feet East of the Southwest corner of the Southeast quarter of said Section 28; thence East 75 feet to the West boundary of the road formerly designated as State Highway No. 8; thence Southerly along the West boundary of said road to intersection with the Northerly right-of-way line of said road to intersection with the Northerly right-of-way line of Primary State Highway No. 8 as presently established; thence Southwesterly following the Northerly right-of-way line of said Highway 200 feet, more or less, to a point South 07° 30' East from the point of beginning; thence Southwesterly along the Northerly right-of-way of said Highway 100 feet; thence North 07° 30' West 400 feet, more or less, to intersection with the South line of the tract of land first above described; thence East to the point of Beginning.
