For the sum of one dollar and other valuable consideration, Grantors, Dennis McNeill and Tina McNeill, hereby grant and convey to Grantee, Northwest Natural Gas Company, and its successors and assigns, an easement to install, operate, maintain, replace and change the size of a gas pipeline or pipelines and related equipment in and upon the following described property:

The westerly 10 feet of Lot 1 of the McNeill Short Plat recorded in B3 of Short Plats, Page 192, Skamania County Records in the nonthwest quarter of Section 20, Township 3 North, Range 8 East, Willamette Meridian, in Skamania County, Washington.

This easement includes the right of the Grantee to enter and use the property of the Grantor to do or to take any of the actions described in this document.

Grantee will install the pipeline with the least amount of disturbance to Grantors' property as possible and will, to the extent practical, restore Grantors' property to the condition existing prior to Grantee's construction. Grantee will reimburse Grantors for any damage to their property caused by Grantee during its use of the easement.

Grantor agrees that they will not place any building or other structures or potentially large growing trees upon the easement and that no actions will be allowed that would jeopardize or interfere with the safe operation of the pipeline.
