THIS SUPPLEMENTAL AGREEMENT, made and entered into this 9th day of February 19 9 by and between LONGVIEW FIBRE COMPANY, a Delaware corporation, herein called "Longview Fibre," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 7th day of November, 1984, Longview Fibre and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington on the 26th day of November, 1984, in Volume 84 of Deeds, Pages 98-127, under Auditor's File No. 98520, and in the records of Klickitat County, Washington, on the 10th day of December, 1984, in Volume 229 of Deeds, Pages 67-96 under Auditor's File No. 196474, and in the records of Clark County, Washington, on the 27th day of December, 1984, on Pages 163-192 under Auditor's File No. 8412270113. Said Original Easement is hereby supplemented as follows:

Longview Fibre for and in consideration of the grant hereinafter made by the State, hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across W½ SE¼, SE¼ SW¼ Section 18, Lcts 1, 2, 3, and 4, E½ NW¼ Section 19, all in Township 2 North, Range 6 East, W.M., NW¼ SE¼ Section 23, SE¼ SE¼ Section 24, NE¼ NE¼, W½ NW¼, NW¾ SW¼, NW¼ SE¼ Section 25, N½ SE¼ Section 26, all in Township 2 North, Range 5 East, W.M., and SE¼ NW¼, NW¼ NE¼ SW¼ Section 24, Township 3 North, Range 7 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record,

State, for and in consideration of the grant hereinabove made, hereby grants and conveys to Longview Fibre, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width over and across SE% NW% Section 25, N% NE%, SE% NE% Section 26, all in Township 2 North, Range 5 East, W.M., in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road located approximately as shown in green on the attached "Exhibit B."

Subject as to said lands to all matters of public record.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.

Thirty (30) days prior to any reconstruction, and/or betterment of said road by either party on lands of the other party, the initiating party will submit to the landowning party a written request for joint review of the proposed project, upon completion of which the initiating party will submit a complete and detailed plan of operations. Each parties' operations, specified herein shall be conducted in accordance with the provisions of the approved plan of operations. Said parties shall provide the other party the right of examination of the right of way before any construction, or development is commenced.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.






