DEED OF PERSONAL REPRESENTATIVE

THE GRANTOR, Craig R. Salvesen, as Personal Representative of the Estate of Avary Skaalheim, in consideration of settlement of estate, conveys to Karla Salvesen Langer, a married woman as her separate property, and to Craig R. Salvesen, a married man as his separate property, an undivided one-half interest each, as tenants in common, in the following described real estate situated in Skamania County, Washington:

That portion of Government Lots 4 and 9 in Section 36, Township 3 North, Range 7-1/2 East of the Willamette Meridian, Skamania County, Washington, more particularly described as follows:

Beginning at a point 287 feet East and 417.5 feet North of the intersection of the North line of the Henry Shepard D.L.C. and the Second Guide Meridian East; thence north 417.5 feet; thence East 417.5 feet; thence South 417.5 feet; thence West 417.5 feet to the point of beginning; EXCEPTING THEREFROM that parcel deeded to Hans H. Strauss, et ux., in Book 63 of Deeds at Page 921, records of Skamania County, Washington.

ALSO the East 150 feet of the South 417.5 feet of Government Lot 9 in said Section 36 except that portion thereof lying South of the North line of Strawberry Loop Road;

ALSO that portion of Lot 8 of said Section 36 lying northerly of Strawberry Loop Road and westerly of Bond Road.

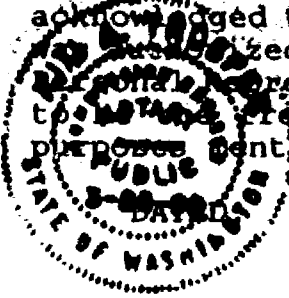
