Beginning at a point on the West line of the Northwest quarter of the Northwest quarter of Section 28, South 00° 18' 51" East 494.22 feet from the Northwest corner thereof; thence South 89° 45' 28" East 1300.53 feet to the East line of the said Northwest quarter of the Northwest quarter; thence South 00° 18' 24" West along said East line 320.39 feet; thence North 89° 27' 15" West parallel with the South line of said Northwest quarter of the Northwest quarter 1,464.96 feet to the centerline of Duncan Creek County Road; thence along said centerline North 72° 44' 54" West 171.50 feet; thence along the arc of a 100 foot radius curve to the right for an arc distance of 86.42 feet; thence along the arc of a 300 foot radius curve to the left for an arc distance of 213.80 feet; thence along the arc of a 150 foot radius curve to the right for an arc distance of 110.58 feet; thence (leaving said centerline) South 87° 36' 07" East 610.77 feet to the Point of Beginning.
