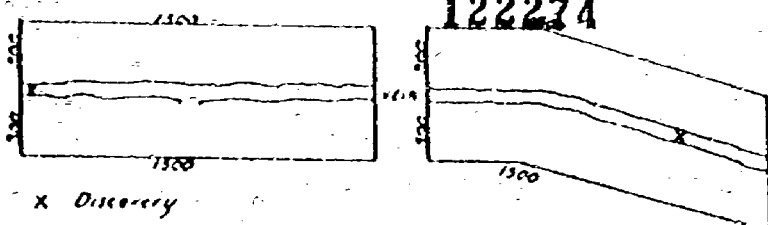

NOTICE IS HEREBY GIVEN That the undersigned who is/are (has declared intention to become) citizen of the United States, has discovered and has located and claimed and does hereby locate 1500 linear feet in length, and 600 feet in width on the

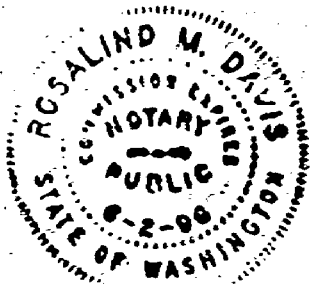
