ATTACHMENT TO STATUTORY WARRANTY DEED

PARCEL 1

All that portion of the Southwest Quarter of Section 23, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Mashington, which lies South and East of Berge Road; EXCEPTING THEREFROM that portion conveyed to the public by deed recorded March 18, 1908 in Book 1, Page 51, Skamania County Deed Records; ALSO EXCEPTING THEREFROM that portion conveyed to Skamania County by deed recorded May 28, 1980 in Book 78, Page 269, Auditor's File No. 90809, Skamenia County Deed Records; ALSO EXCEPTING THEREFROM that portion lying Northerly of an unnamed stream channel, as sold to Laroy Anderson, et. al., by contract recorded December 31, 1984 in Book 84, Page 218, Auditor's File No. 98749, Skamenia County Deed Records; ALSO EXCEPTING THERE FOR Lot 1 of BEENICE BERGE SHORT PLAT, according to the Plat thereof, recorded May 14, 1986, in Book 3, Page 93, Auditor's File No. 101131, Skamania County Plat Records; and ALSO EXCEPTING THEREFROM that portion conveyed to Skamania County Cumatery District by deed recorded 5-17-93 in Book 135, Page 360, Auditor's File No. 116 248 Skewenia County Deed Records; and SURJECT TO An easement of 30 feet in width for ingress and egress within a portion of the Southwest quarter of the Southwest quarter of Section 23, T3N, RSE, W.M., in the County of Skamenia and the State of Washington, described more particularly as follows:
