MCGILL, husband and wife, the following described real estate, situated in the County of Skamania, State of Washington:

A Tract of land in Government Lot 8 in Section 36, Township 3 North, Range 7-1/2 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at a point 126.6 feet North of the Southwest corner of Lot 8 in said Section 36; thence East 100.4 feet; thence North 24°06' West to a point 33 feet East of the West line of Lot 8; thence North to the North line of Lot 8; thence West 33 feet to the Northwest corner of Lot 8; thence South to the point of beginning.

EXCEPT that portion lying within Roads.

TOGETHER WITH an easement over, under and across an area approximately 65' x 65' located in the southeast corner of Grantors' property described in Exhibit "A" attached hereto and incorporated herein, for ingress, egress, access, utilities and maintenance of a drainfield extension serving the property being conveyed by this deed. This easement is for the sole benefit of the property conveyed to Grantees hereunder and will terminate at such time as Grantees or their heirs, successors or assigns hook onto a public sewer system or an alternate septic system not requiring an extension of said drainfield.

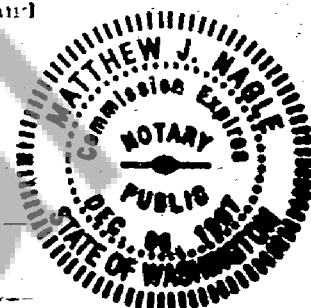
