by the location and establishment of the above proposed County Road, hereby consent that said road be established as
described in the petition herein and as examined and surveyed, and forever relinquish to Skamania County, Washington,
a Right-of-Way _____ 30 feet additional _____ feet in width over and across the following
described piece or parcel of land, to-wit:

A strip of land 30 feet in width, lying parallel to and contiguous with the east
right-of-way line of Spruce Street as shown in the plat of the second edition of
Hillcrest Acre Tracts. Said additional right-of-way beginning on the east right-
of-way 90 feet southeasterly of the northwest corner of Lot No. 4, Block No. 5 of
said plat. Thence continuing southeasterly along the east right-of-way line of
Spruce Street for 50 feet. This additional right-of-way to be used for the
construction of a turn around. If Spruce Street is continued on to connect with
another street, thus making a loop or necessitating a turn around in another loca-
tion, this additional right-of-way will revert to the grantors of this waiver.

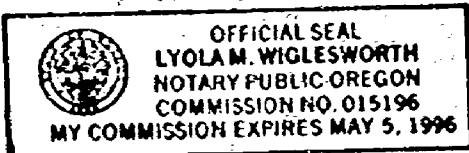
