together with all income, cents and profits from it; all plumbing, lighting, sir conditioning and heating apparatus and equipment; and all fencing, blinds, drapes, floor coverings, built-in appliances, and other fixtures, at any time installed on or in or used in connection with such real property, all of which at the option of Beneficiary may be considered to be either personal property or to be part of the real estate.

All of the property described above will be called the "Property". If any of the Property is subject to the Uniform Commercial Code, this Deed of Truet is also a Security Agreement which grants Servaticiary, as ancured party, a security interest in all such property.

2. Obligation Secured. This Deed of Trust is given to secure performance of each promise of Grantor contained herein or in a Lifetine/Lifetine Plus Home Equity Line of Credit Agreement with Beneficiary with a maximum credit limit of \$ 25,000,00

(the "Credit Agreement"), including any extensions, renewals or modifications thereof, and repayment of all sums borrowed by Grantor under the Credit Agreement, with interest from the date of each advance until paid at the rates provided therein. The Credit Agreement provides for a variable rate of interest. Under the Credit Agreement, the Grantor may borrow, rappy and re-borrow from time to time, up to the maximum credit limit stated above, and all such advances shall be secured by the lien of this Deed of Trust. This Deed of Trust also secures payment of certain fees and closes of Beneficiary as provided in Section 3 of this Deed of Trust, and repayment of money advanced by Beneficiary to protect the Property or Beneficiary's interest in the Property, including advances made pursuant to Section 6 below. The Credit Agreement provides that unless sooner repaid, the Debt is due and payable in full thirty (20) years from the date of this Deed of Trust (the "Meturity Dete"). All of this money is called the "Debt".

(a) Grantor is the owner of the Property, which is unencumbered except by: easements reservations, and restrictions of record not itsent with the intended use of the Property and any existing first mortgage or deed of trust given in good faith and for value, the of of which has been disclosed in writing to Beneficiary; and

(b) . The Property is not used principally for agricultural or farming purposes.

4. Promines of Grantor. Grantor promises:

(a) To keep the Property in good repair and not to remove, after or demolish any of the improvements on the Property, without first siring Beneficiary's printen consent;

(b) To allow representatives of Beneficiary to inspect the Property at any reasonable hour, and to comply with all laws, ordinances, ulations, coverants, conditions and restrictions affecting the Property;

(c) To pay on time all lawful taxes and assessments on the Property;

(d) To perform on time all terms, coverants and conditions of any prior mortgage or deed of trust covering the Property or any part of and pay all gineunts due and owing thereunder in a timely manner;

(e) To see to it that this Deed of Trust remains a valid tion on the Property superior to all tions except those described in Section 3(a); obtaining Bo (b)

(f) To keep the improvements on the Property Insured by a company estisfactory to Beneficiary against fire and extended coverage rile, and against such other risks as Beneficiary may reseembly require, in an amount equal to the full insurable value of the improvements, if the deliver evidence of such insurance coverage to Beneficiary shall be named as the lose payer on all such policies pursuant to standard lender's less payable clause.

5. Transfer or Further Ensurances of Property. Granter additionally provises not to sell, transfer or further encumber the Property or any street in the Property.

6. Cusing of Botaults. If Granter falls to comply with any of the covenants in Section 4, including all the terms of any prior mertgage or deed of trust, Beneficiary may take any action required to comply with any such covenants without waiving any other right or remedy it may have for Granter's fallure to comply. Repayment to Beneficiary of all the money spent by Beneficiary on behalf of Granter shall be accured by this Deed of Trust. The amount spent shall beer interest at the rates from time to time applicable under the Credit Agreement and be repayable.
