

Indemnification and Hold Hurmless Agreement

Skamania County agrees and covenants that it shall indemnify and save harmless the State, its employees, officers, agents from any and all liability, damage, expense, cause of action, suit, claim, judgment, or other economic effect, by any reason whatsoever caused, arising out of the use, occupation, and control of the property as a landfill or similar use, including but not limited to: (1) claims and actions against the State arising out of activities of Skamania County, its lessees, invitees, agents, employees, licensees, or permittees on the property; (2) adverse impacts to adjacent State lands; and (3) adverse impacts to adjacent private properties.


