DECLARATION OF COVENANT

FOR PRIVATE MAINTENANCE OF SHORT PLAT APPROVED PRIVATE ROAD
"SUNDAY DRIVE"

Declaration of Covenant

"In consideration of the approval by Skamania County of Short Plat # SP 9442, which said plat creates four (4) lots described as follows:

(See Legal Description as recorded in Book No. 128
Page 597 of Skamania County deed of records.)

the undersigned owners and developers covenant and agree that:

1. Each lot owner shall be responsible for maintenance of the private road named "Sunday Drive" within said short plat on an equal basis.

2. Maintenance methods, standards, and financing shall be in a manner determined by the owners of a majority of the lots within such aforescribed property.

3. Owners of lots within the above referenced short plat, who are served by such private road, may sue and recover from any owner of any lot within the short plat which is similarly served who refuses to participate in the maintenance. Such owners who refuse to share the costs under the percentage set forth above shall be liable for any attorneys fees.

4. Skamania County has no responsibility to build, improve, maintain, or otherwise service the private roads contained within or providing service to the above referenced property."

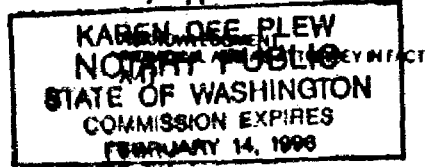

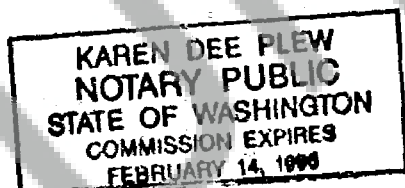
