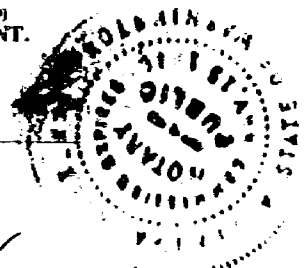

PARCEL I
