Beginning at the Southeast Corner of the Northeast Quarter of the Northeast Quarter; thence Westerly along the South Line thereof a distance of 195 feet to the West Line of that certain tract of land as conveyed to Douglas W. McCuistion et. ux., by deed recorded in Book 65 of Deeds, Page 377, Auditor's File No. 76238; thence Northerly along the West Line of the McCulation Tract to the Northeast Corner of that certain tract of land as conveyed to Kenneth A. Barstow et. ux., by deed recorded in Book 73, Page 93, Auditor's File No. 84494, said point being 425.50 feet Northerly of the centerline of county road known as School House Road (County Road No. 3371) as deeded to Skamania County by deed recorded in Book 66 of Deeds, Page 398, Auditor's File No. 77192, and said point being the true point of beginning of the tract herein described; thence Westerly along the North Line of said Kenneth A. Barstow Tract a distance of 458.63 feet to the Northeast Corner thereof; thence Northerly on a line a distance of 190 feet, more or less, to its intersection with a point on the South Line of the Northeast Quarter of the Northeast Quarter of the Northeast Quarter of said Section 21, said point being the Southeast Corner of that certain tract of land as conveyed to Myron R.
