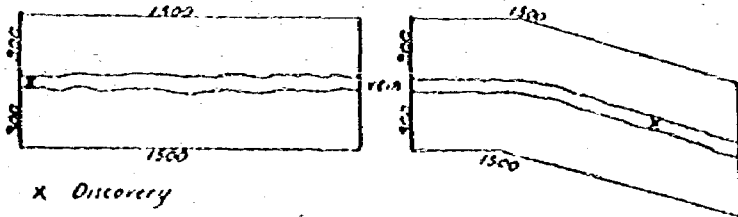

NOTICE IS HEREBY GIVEN That the undersigned who is/are (has/declared intention to become) citizen<sup>s</sup> of the United States, has discovered and has located and claimed and does hereby locate \_\_\_\_\_ linear feet in length, and \_\_\_\_\_ feet in width on the STAR GATE I, II, III PLACER CLAIM ASSOCIATION. 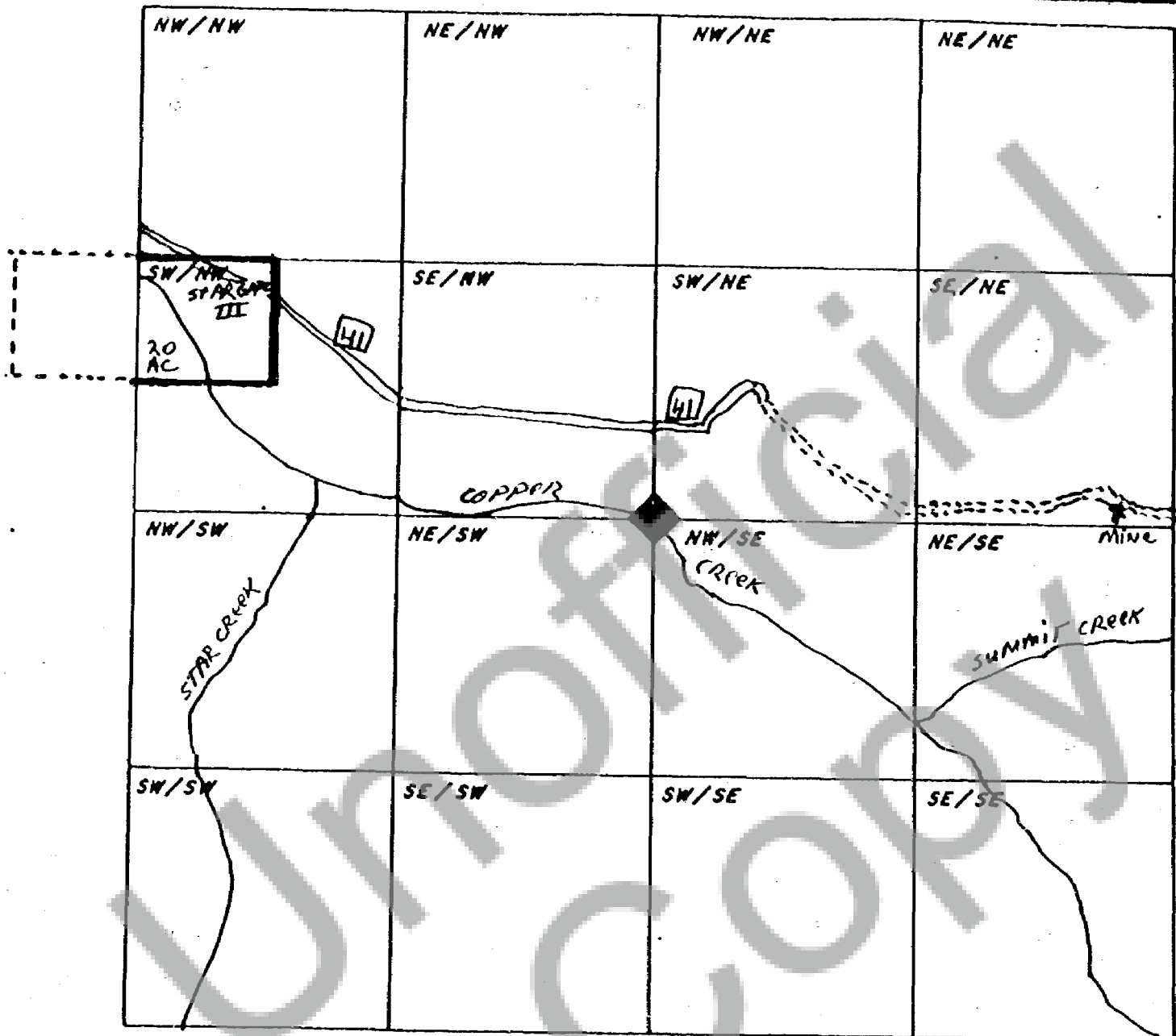

Township 4N Range 5E Section 32 State of WASHINGTON



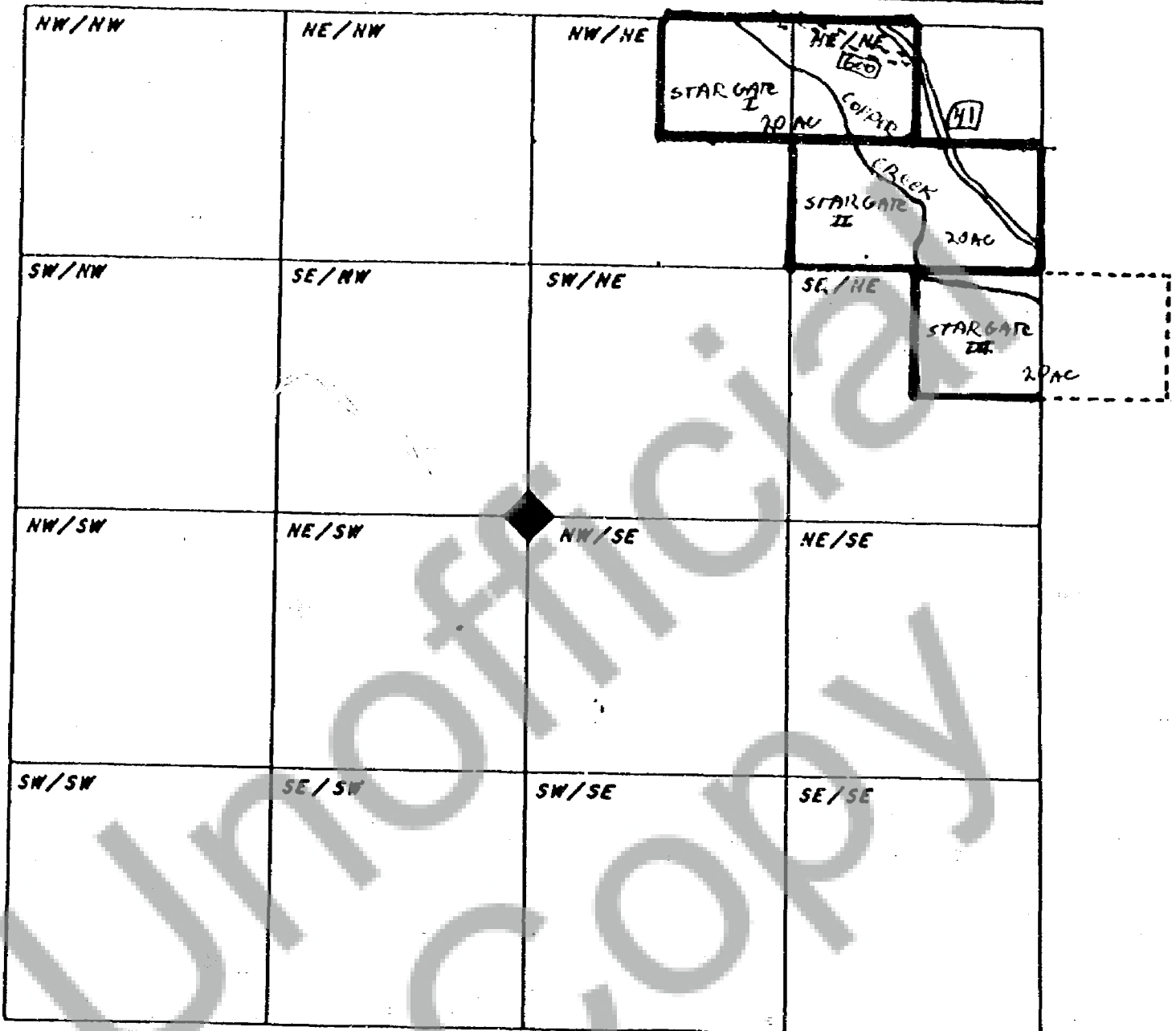
