LICENSE AGREEMENT BOOK 153 PAGE 121

This agreement is made and entered into this 23<sup>rd</sup> day of October, 1995, by and between STAN ANDERSEN, a married man, hereinafter referred to as "Licensor", and DAVID PROSSER and LAURA PROSSER, husband and wife, hereinafter referred to as "Licensees", and their assigns.

In consideration of the mutual benefits and obligations set forth in this agreement, the parties agree as follows:

SECTION ONE  
GRANT OF LICENSE

Licensor grants to Licensees the exclusive privilege to use the following described real property for the purposes of ingress and egress to Licensees' property, which is more particularly described as Lot 3 of the Stan Andersen Short Plat, recorded in Book 3, at page 143, Plat Records of the Skamania County Auditor, to-wit:

a portion of that road lying in Section 29, Township 3 North, Range 8 EWM, running southeasterly off Patricia Road across a corner of Lot 4 of the Stan Andersen Short Plat and PP&L's power line; said roadway lying northerly of Licensees' property, and currently providing access to a barn located on said Lot 3, as depicted on the attached map, marked Exhibit "A" and by this reference incorporated herein.

ROAD MAINTENANCE

Licensees shall, at their sole cost and expense, keep the above-described road in good condition and repair at all times during the life of this license.

SECTION THREE  
DURATION OF LICENSE

This license shall begin upon the execution hereof and shall continue until terminated as provided in this agreement. The license may be assigned only upon the written approval of the licensor.

SECTION FOUR  
INDEMNIFICATION OF LICENSOR

Licensees shall indemnify Licensor against all claims for damages to the subject property or injury to third persons resulting from or arising out of the use of said roadway.

SECTION FIVE  
TERMINATION OF LICENSE

This license shall terminate upon thirty (30) days advance written notice by either party to the other.
