EASEMENT SUPPLEMENT

THIS SUPPLEMENTAL AGREEMENT, made and entered into this 20th day of November, 1995, by and between LONGVIEW FIBRE COMPANY, a Washington corporation, herein called "Longview Fibre," and STATE OF WASHINGTON, acting by and through the Department of Natural Resources, herein called "State," WITNESSETH:

Whereas, on the 7th day of November, 1984, Longview Fibre and the State entered into an easement exchange hereinafter called Original Easement, which was recorded in the records of Skamania County, Washington, on the 26th day of November, 1984, in Volume 84 of Deeds, Pages 98-127 under Auditor's File No. 88520, and in the records of Klickitat County, Washington, on the 10th day of December, 1984, in Volume 229 of Deeds, Pages 67-96 under Auditor's File No. 19674, and in the records of Clark County, Washington, on the 27th day of December, 1984, on Pages 163-192 under Auditor's File No. 8412270113. Said Original Easement is hereby supplemented as follows:

- A. Longview Fibre for and in consideration of Five Hundred and no/100 Dollars (\$500.00) hereby grants and conveys to State, its successors and assigns, a permanent easement upon, over, and along rights of way sixty (60) feet in width, over and across NE1/4 SW1/4 Section 26, Township 2 North, Range 5 East, W.R. in Skamania County, Washington, being thirty (30) feet on each side of the centerline of a road located approximately as shown in red on the attached "Exhibit A."

Subject as to said lands to all matters of public record.

Except as herein supplemented all of the terms, conditions and reservations of the Original Easement shall remain in full force and effect.


