BROUGHTON LUMBER CO., does hereby convey, warrant, and donate unto the UNITED STATES OF AMERICA, Grantee, and its assigns, pursuant to Sec. 11 of the Department of Agriculture Organic Act of August 3, 1956 (P.L. 84-979, Ch. 950, 70 Stat. 1032; 7 U.S.C. 428a); all of the following described real property in the County of Skamania, State of Washington, free of encumbrances except as specifically set forth herein:

sec. 35, That portion of the N1/2NW1/4SE1/4SE1/4, the SE1/4NW1/4SE1/4SE1/4, the SW1/4NE1/4SE1/4SE1/4, the NW1/4SE1/4SE1/4SE1/4, and the SE1/4SE1/4SE1/4SE1/4 lying west of the Westerly right-of-way boundary of Oklahoma Road County Road No. 3086 (AKA National Forest Service Road No. 18), as shown approximately on the attached Exhibit A, consisting of 1 sheet.

THE PURPOSE OF THIS DEED IS TO AFFECT A BOUNDARY LINE ADJUSTMENT BETWEEN THE ADJOINING PROPERTY OF THE GRANTOR AND GRANTEE HEREIN, AND IS THEREFORE EXEMPT FROM THE REQUIREMENTS OF RCW 58.17 AND THE SKAMANIA COUNTY SHORT PLAT ORDINANCE. THE HEREIN DESCRIBED PROPERTY CANNOT BE SEGREGATED AND SOLD WITHOUT FIRST CONFORMING TO THE STATE OF WASHINGTON AND SKAMANIA COUNTY SUBDIVISION LAWS.

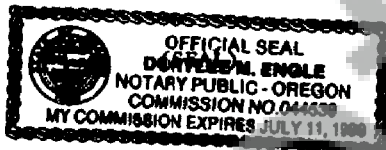

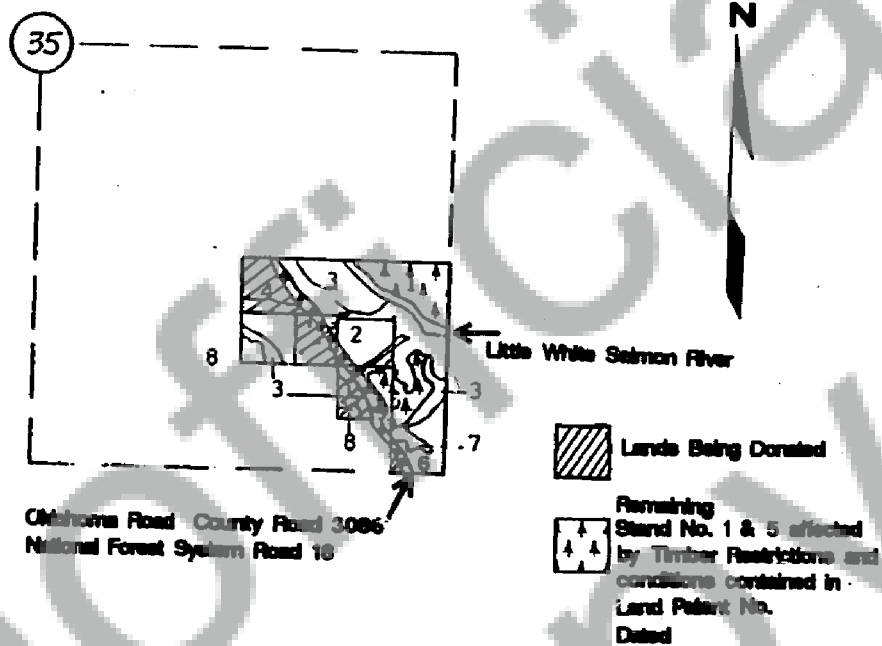
