Lot 1 of the CUMMINGS SHORT PLAT, recorded in Book 2 of Short Plats, Page 207, Skamania County Records.

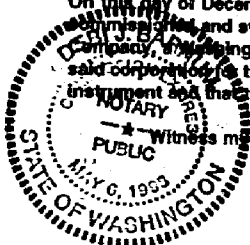
