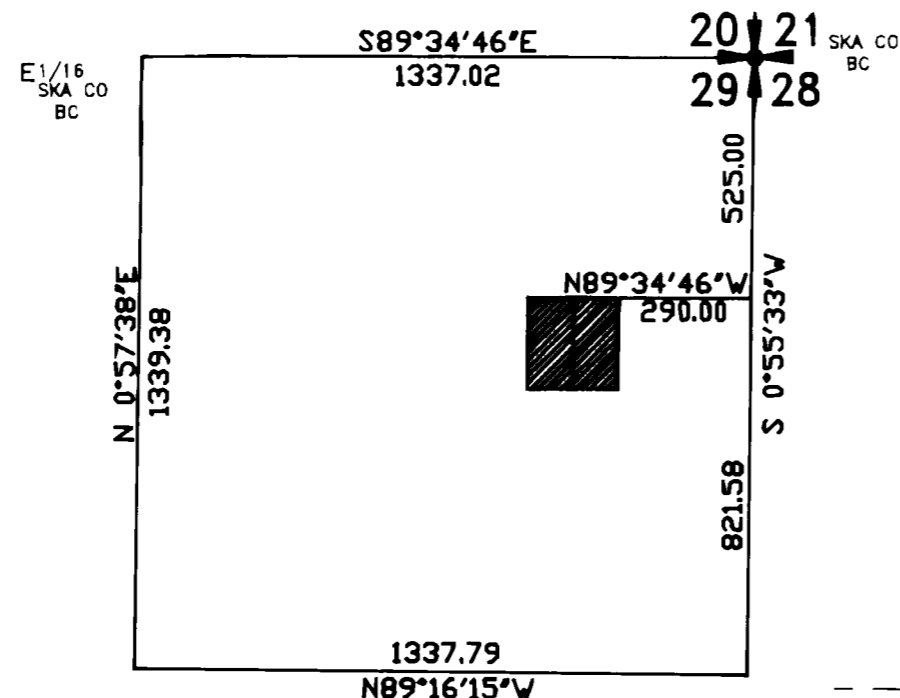

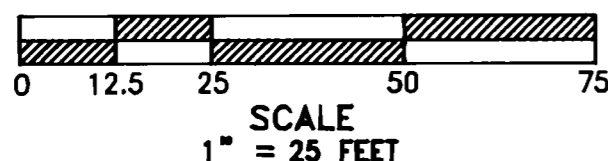

TRAVERSE STATEMENT & SURVEY NARRATIVE:

A closed field traverse for the parcels shown was made with a 10" total station and related measuring equipment, all of which met state standards (WAC 332-130-090) at the time of this survey. Acceptable raw closure in excess of 1:10000 was balanced by compass adjustment procedure to effect mathematical closure. Field work for this project was conducted during the period of June 16- November 10, 1994. The only encroachment noted during this survey is that of the carport extending onto Frederick Avenue.

Land within this subdivision shall not be further subdivided for a period of 5 years unless a final plat is filed pursuant to Skamania County Code, Title 17, Subdivisions, Chapter 17.04 through 17.60 inclusive.
