NOTICE IS HEREBY GIVEN THAT, on December 27, 1995, New Snowflake No. 2, Lode Claim, St. Helens Mining District, Skamania County, Washington, was located by a citizen of the United States, known as, MTM Enterprises, a Partnership, P.O. Box 120, Kelso, WA., 98626.

NOTICE IS FURTHER GIVEN, That the undersigned, having complied with the requirements of Chapter six of Title thirty-two of the Revised Statutes of the United States, 30 U.S.C. 21-54, and 43 U.S.C. 1701 et seq., 96 Stat. 301, and the laws of the State of Washington, and the local customs and regulations of said District, has discovered and does hereby locate 1500 linear feet in length, and 600 feet in width on a lode, vein, ledge, or deposit, known as New Snowflake No. 2, Lode, vein, ledge or deposit, situate in St. Helens Mining District, Skamania County, Washington, and further described at a point of beginning, as follows:

Commencing at corner #1, which abounds Lot 8 and is corner #1 New Little Giant No. 1 Lode, thence N 79 degrees West, along the south line of New Little Giant No. 1 Lode, 1500 feet or less to the boundary of the Mount. St. Helens National Volcanic Monument to corner #2, thence South and East along said boundary approximately 600 feet to the North line of Patent #1237223 Lot 7, to corner #3, thence South and East along North line of Lot 7 approximate 100 feet to corner #4, which is a point that is in line with the north line of New Mountain Chief No. 2 Lode and New Osceola Lode, thence N. 69 degrees East 1500 feet or less to corner #1, the point of beginning.

This claim is further described as being located upon known, segregated, and reserved mineral lands in the N.W. 1/4, of Section 13, Township 10N., Range 5E., of W.M.
