The Director of the Office of Thrift Supervision issued Order number(s) 90-371 dated February 21, 1990, placing Benjamin Franklin Federal Savings and Loan Association, Portland, OR in conservatorship and appointing Resolution Trust Corporation as Conservator for Benjamin Franklin Federal Savings and Loan Association.

The Director of the Office of Thrift Supervision issued Order number(s) 90-1658 dated September 7, 1990, placing Benjamin Franklin Federal Savings and Loan Association in receivership and replacing the Conservator of Benjamin Franklin Federal Savings and Loan Association with the Resolution Trust Corporation as Receiver of Benjamin Franklin Federal Savings and Loan Association pursuant to subdivision (F) of Section 5(d) of the Home Owners' Loan Act, as amended.

RESOLUTION TRUST CORPORATION, in its capacity as Receiver of Benjamin Franklin Federal Savings and Loan Association having a mailing address of 500 W Monroe Suite 3200 Chicago, IL 60661 is the owner and holder of a certain Deed of Trust dated JULY 9, 1987 executed by WINSTON KENT RALL, AS AN INDIVIDUAL, as Grantor in favor of MT. ADAMS TITLE COMPANY, as Trustee, for the benefit of THE BENJ.
