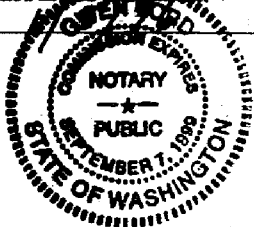

PARCEL I

Lot 20 of Block One of River Glen on the Washougal, according to the official plat thereof on file and of record at page 132 of Book "A" of plats, Records of Skamania County, Washington.

Except that portion thereof lying Easterly of the following described line:

Beginning at a point on the curve of the Northerly line of the said Lot 20 which is 27.90 feet Westerly, when measured along said curve line, from the Northeast corner of said Lot; thence South 22°30' West 100 feet; thence South 15°58'30" East, parallel with the Easterly line of said Lot, 240 feet, more or less, to the thread of the Washougal River.

PARCEL II

A tract of land located in the Southwest quarter of the Southwest quarter of Section 23, township 2 North, Range 5 East of the Willamette Meridian, described as follows:

Beginning at a point on the West line of the said Section 23; North 560 feet from the Southwest corner of the said Section 23, said point being the Northwest corner of a tract of land conveyed to Woodrow I. Taylor by deed recorded at page 204 of Book 57 of Deeds, Records of Skamania County, Washington; thence North along the section line aforesaid 173-63 feet, more or less, to the Southwest corner of Lot 20 of River Glen on the Washougal according to the official plat thereof recorded at page 132 of Book A of Plats, records of Skamania County, Washington; thence following the South line of the said Lot 20 South 89°56'25" East 114.20 feet, more or less, to the center of the channel of the Washougal River; thence in a Southerly direction following the center of the channel of the Washougal River to a point East of the Point of Beginning; thence West to the Point of Beginning.
