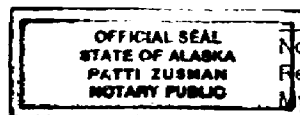

**EXHIBIT A**

That portion of the Northeast Quarter of Section 11, Township 1 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at a point on the North boundary of the North Bank Highway right of way which is South  $85^{\circ} 52'$  West 195.5 feet from the Northwest corner of the property owned in the year 1923 by School District 9; thence North  $38^{\circ} 03'$  West 116 feet along the Old Gunther-Gattanini Road; thence North  $08^{\circ} 01'$  West 150 feet; thence South  $81^{\circ} 59'$  West 200 feet; thence South  $16^{\circ} 21'$  East along a creek at a distance of 6 feet from the center of said creek a distance of 100 feet; thence South  $32^{\circ} 01'$  East continuing along the aforesaid creek 6 feet from its center for a distance of 166 feet to the North boundary of the North Bank Highway right of way; thence North  $83^{\circ} 29'$  East along said North right of way 170 feet to the point of beginning.

EXCEPT that portion conveyed to the State of Washington by deed recorded November 20, 1925 in Book U, Page 464, records of Skamania County, Washington.
