Lot 4 of the JEREMIAH JOHNSON SHORT PLAT as recorded in Book 2 of Short Plats on Page 41, Skamania County Records.



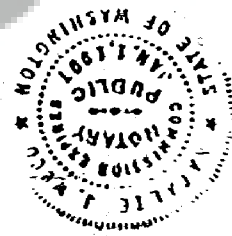


