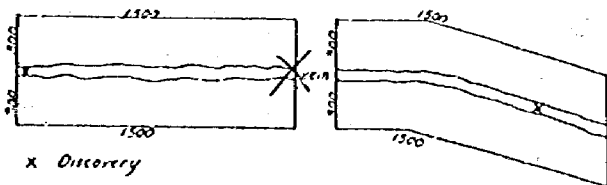

Quartz vein.
