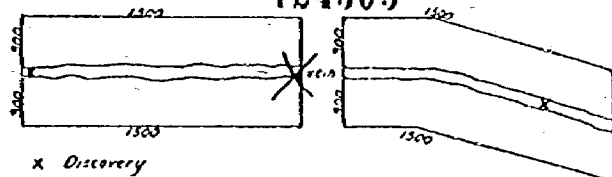

Quartz vein
