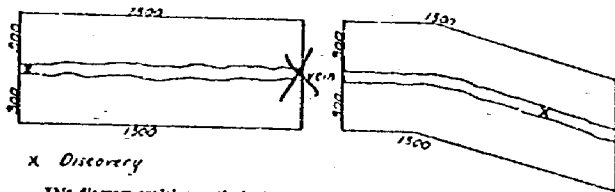

Quartz vein
