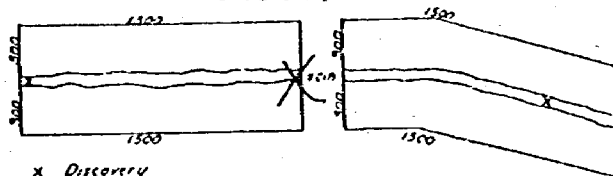

NOTICE IS HEREBY GIVEN That the undersigned who (s)are (ha___ declared ___ intention to become) citizen___ of the United States, has discovered and has located and claimed and do___ hereby locate 1,500 linear feet in length, and 600 feet in width on the
