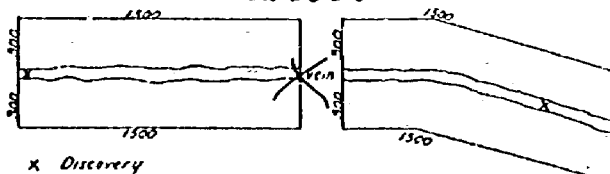

quartz vein___ .
