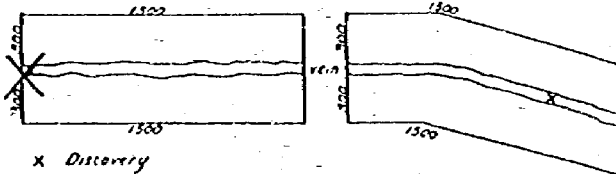

NOTICE IS HEREBY GIVEN That the undersigned who is are (ha\_\_\_ declared \_\_\_ intention to become) citizen\_\_\_ of the United States, has discovered and has located and claimed and do\_\_\_ hereby locate 1,500 linear feet in length, and 600 feet in width on the \_\_\_ quartz vein \_\_\_.
