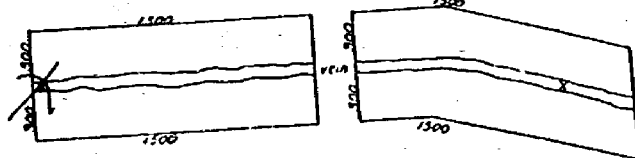

NOTICE IS HEREBY GIVEN That the undersigned who is are (ha declared intention to become) citizen of the United States, ha s discovered and ha s located and claimed and do hereby locate 1,500 linear feet in length, and 600 feet in width on the quartz vein
