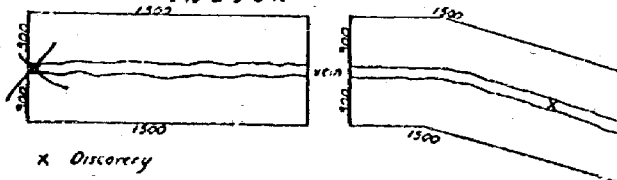

NOTICE IS HEREBY GIVEN That the undersigned who ~~is~~ are (has declared intention to become) citizen of the United States, has discovered and has located and claimed and do hereby locate 1,500 linear feet in length, and 600 feet in width on the quartz vein
