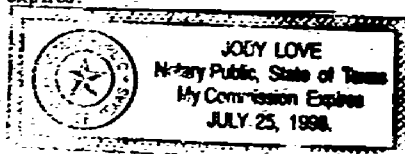

Beginning at a point 859.4 feet North and 30 feet East of the Southwest corner of the Southeast Quarter of the Southeast Quarter of Section 26, Township 2 North, Range 6 East of the Willamette Meridian, in the County of Skamania, State of Washington; thence North 70 degrees 46' East 200 feet along the county road known and designated as Little Street; thence South 17 degrees 47' East 167 feet; thence South 70 degrees 46' West 251.05 feet; thence North 167 feet to the Point of Beginning.
