QUIT CLAIM DEED

The Grantor, ODILE ELEANORE SZYDLO (formerly Odile Eleanore Rutledge), a widow, for and in consideration of Love and Affection, Gift from Mother to Daughter, conveys and quit claims to CHERIE CECILIA SCHROEDER, as her separate estate, the following described real estate, situated in the County of Skamania, State of Washington, including any after acquired title:

Beginning at a point 1,800 feet South of the quarter corner common to Sections 30 and 31, T3N, Range 8 EWM; thence North 55 deg. 30' East 1,007 feet to the Northeast corner of a tract of land conveyed to C.M. Youmans by deed recorded at Page 11 of Book R of Deeds, records of Skamania County, Washington, said point being the initial point of the tract hereby described; thence South to the meander line of the Columbia River; thence following the meander line of the Columbia River upstream to a point 200 feet East of Smith Creek; thence northerly following a line parallel to and 200 feet distant, measured easterly at a right angle, from the center of the channel of Smith Creek to intersection with the southerly right-of-way line of Primary State Highway 8; thence following the southerly right-of-way line of said highway in a westerly and southerly direction to a point on the easterly boundary thereof which is South 55 deg. 30' West from the initial point; thence North 55 deg. 30' East to the initial point; EXCEPT all minerals and mineral deposits therein and thereon; AND EXCEPT the right-of-way acquired by the Spokane, Portland & Seattle Railway Co.; SUBJECT TO easements of record; AND AS ADJUSTED by Quit Claim Deed and Boundary Line Adjustment, between David G. Larive and Eleanore Szydlo, dated April 22, 1986, and recoded May 23, 1986, in Book 101, Page 220, Auditor's file #101156, records of Skamania County, Washington

AND EXCEPT a tract of land located in Section 31, T3N, Range 8 EWM, more particularly described as: Beginning at a point 1,800 feet South of the quarter corner common to Sections 30 and 31, T3N, Range 8 EWM; thence North 55 deg. 30' East 1,007 feet to the Northeast corner of a tract of land conveyed to C.M. Youmans by deed recorded at Page 11 of Book R of Deeds, records of Skamania County, Washington; thence East 350 feet to the initial point of the tract hereby described; thence North 180 feet; thence East to the center of the channel of Smith Creek; thence following the center of the channel of Smith Creek in a southeasterly direction to intersection with the northerly line of the right-of-way acquired by the Spokane, Portland & Seattle Railway Co.; thence following the northerly line of said railway


