Parcel I

A tract of land in the Southeast Quarter of the Southeast Quarter of Section 27, Township 3 North Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Beginning at the Southeast corner of the said Section 27; thence West along the South line of the said Section 27 with an assumed bearing of due West, a distance of 810 feet; thence due North 69.15 feet to an iron pipe driven in the ground and the initial point of the tract hereby described; thence North 66 degrees 01' West 68.1 feet; thence North 15 degrees 26' East 50.2 feet; thence South 23 degrees 59' East 61.2 feet; thence South 66 degrees 01' East 100 feet; thence South 23 degrees 59' West 100 feet to the initial point.

Parcel II

A tract of land in the Southeast Quarter of the Southeast Quarter of Section 27, Township 3 North, Range 8 East of the Willamette Meridian, in the County of Skamania, State of Washington, described as follows:

Commencing at the Southeast corner of said Section 27; thence along the South line of said Section 27 with an assumed bearing of due West a distance of 810 feet; thence due North a distance of 69.15 feet to an iron pipe driven in the ground; thence North 66 degrees 01' West along the South line of that tract conveyed to Pearl Rampley Clay in Book 42, Page 367, Skamania County Records, a distance of 68.1 feet to a 3/8 inch iron rebar, said point being the True point of beginning; thence North 15 degrees 26' West along the Westerly line of said Clay tract a distance of 50.2 feet; thence North 23 degrees 59' East along the Westerly line of said Clay tract a distance of 61.2 feet to the most Northerly corner therein; thence North 66 degrees 00' 52" West a distance of 24.65 feet to a 3/8 inch iron rebar; thence South 03 degrees 40' 20" West a distance of 80.36 feet to a similar iron rebar; thence Southeasterly to the true point of beginning.
