

## **EXHIBIT A**

Legal Description

## PARCEL I

All that portion of Government Lot 2 of Section 29, Township 3 North, Range 8 East Willamette Meridian, lying Northerly of the Northerly right of way line of the Seattle, Portland and Spokane Railway Company.

## PARCEL II

Beginning at a point 20 rods East of the Southwest corner of the Northwest Quarter of the Southwest Quarter of Section 29, Township 3 North, Range 8 East Williamette Meridian; thence North to the Southerly right of way line of Primary State Highway No. 8; thence Easterly following the Southerly right of way line of said highway a distance of 200 feet; thence South to intersection with the South line of the Northwest Quarter of the Southeast Quarter of said Section 29; thence West 200 feet, more or less, to the point of beginning.

## PARCEL III

All that portion of Government Lot 2, Section 29, Township 3 North, Range 8 East of the Willamette Meridian in the County of Skamania, State of Washington, lying Southerly of the Spokane, Portland and Seattle Railway Company Right of Way and Westerly of Carson Creek.
