3. This Court has determined that, as a matter of both law and equity, that the assets of the Belle Centre Congregational Church and Cemetery Association should be liquidated by entering judgment quieting title in the real property in favor of the Skamania County Cemetery District, subject only to the reversionary interest stated in the deed from Laura S. Fitzgerald to the Belle Centre Congregational Church and Cemetery Association, dated July 8, 1907, and recorded by the Skamania County Auditor at Book L of Deeds, Page 40, and only to the extent that reversionary interest may be applicable pursuant to RCW 68.24.080.

IT IS THEREFORE HEREBY ORDERED, ADJUDGED, AND DECREED as follows:

1. Judgment is hereby entered quieting title to the real property known as the Belle Centre Cemetery, described more fully below, in favor of the Skamania County Cemetery District:

A tract of land located in the northeast quarter of the northwest quarter of Section 8, Township 1 North, Range 5 East of the Willamette Meridian, Skamania County Washington, described as follows:

Commencing at a point 1,008 feet west of the quarter section corner on the north line of the said section 8; thence south 30 degrees east 199.8 feet; thence east 252.5 feet; thence north 173 feet; thence west 351 feet to the point of beginning.
