Real estate situated in the County of Skamania, State of Washington, to-wit:

Lot 4 of MAPLE HILL TRACTS NO. 3 according to the official plat thereof on file and of record at page 144 of Book "A" of Plats, records of Skamania County, Washington.

Also a tract of land in Section 25, Township 3 North, Range 7 E.W.M., lying adjacent to and northerly of Lot 4 aforesaid and more particularly described as follows: Beginning at the northeasterly corner of said Lot 4; thence North 22 deg. 20'11" West 200 feet; thence South 68 deg. 15' West 125 feet; thence South 06 deg. 23'41" East 200 feet to the northwesterly corner of said Lot 4; thence North 69 deg. 50' East 180.04 feet to the point of beginning.
