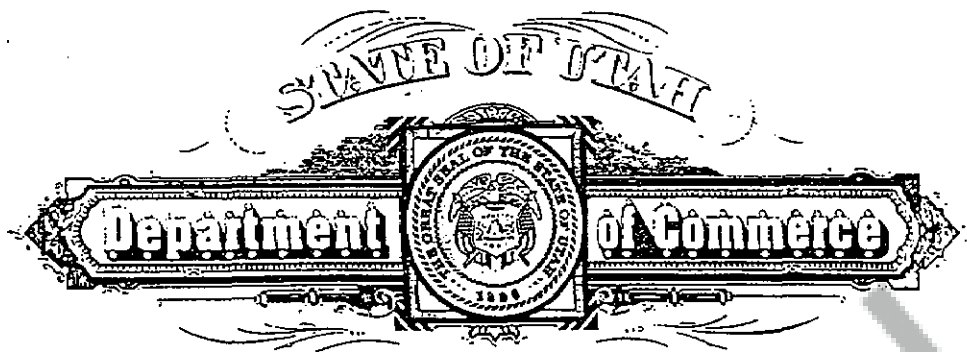

This letter is the official certification of the Comptroller of the Currency (OCC), to merge U.S. Bank of California, Sacramento, California; U.S. Bank of Idaho, Boise, Idaho; U.S. Bank of Nevada, Reno, Nevada; U.S. Bank of Utah, Salt Lake City, Utah; and U.S. Bank of Washington, National Association, Seattle, Washington with and into United States National Bank of Oregon, Portland, Oregon, effective as of June 13, 1997. The resulting bank title is United States National Bank of Oregon and charter number is 4514.

This is also the official authorization given to United States National Bank of Oregon to operate its presently existing branches, the branches of the target institutions and to operate the main offices of the target institutions as branches. A listing of each newly authorized branch and its assigned OCC branch number may be found on Attachment A. 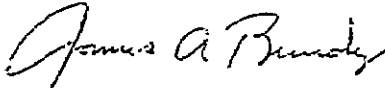

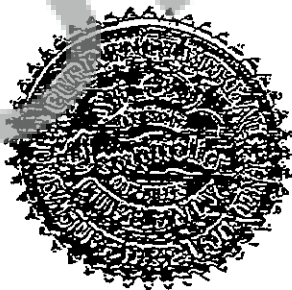

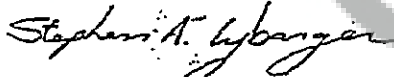
