LEGAL DESCRIPTION

A TRACT OF LAND LOCATED IN THE NORTH HALF OF THE SOUTHEAST QUARTER OF SECTION 20, TOWNSHIP 2 NORTH, RANGE 5 EAST OF THE WILLAMETTE MERIDIAN, SKAMAMIA COUNTY, WASHINGTON, DESCRIBED AS FOLLOWS: BEGINNING AT A POINT IN THE CENTER OF A 40 FOOT COUNTY ROAD KNOWN AS NORTH FORK ROAD WHICH IS 1,718.70 FEET NORTH AND 1,122.65 FEET WEST OF THE SECTION CORNER FOR SECTION 20, 21, 28 AND 29, TOWNSHIP 2 NORTH, RANGE 5 EAST OF THE WILLAMETTE MERIDIAN; THENCE NORTH 89° 50' WEST 485 FEET, MORE OR LESS, TO THE CENTER OF THE NORTH FORK OF THE WASHOUGAL RIVER; THENCE UPSTREAM NORTH 20° EAST 212.8 FEET THENCE SOUTH 89° 50' EAST 550 FEET, MORE OR LESS TO THE CENTER OF SAID NORTH FORK ROAD; THENCE SOUTH 42° 48' WEST 60.21 FEET TO COUNTY ENGINEER'S STATION NO. 49; THENCE SOUTH 29° 36' WEST 187.69 FEET TO THE POINT OF BEGINNING, CONTAINING 2.20 ACRES MORE OR LESS.

THE SELLERS FURTHER GRANT AN EASEMENT FOR WATER PIPE LINE COMMENCING AT THE WEST LINE OF SECTION 21 AT A POINT WHERE HO HANE CREEK INTERSECTS WITH THE WEST LINE OF SECTION 21; THENCE WEST TO THE EAST LINE OF BURNS ROAD; THENCE SOUTHERLY ALONG THE EAST LINE OF BURNS ROAD TO THE ABOVE DESCRIBED PROPERTY AND ALSO THE RIGHT TO THE USE OF CERTAIN WATER FOR DOMESTIC PURPOSES NOT EXCEEDING THE QUANTITY THAT WOULD GO THROUGH A ONE INCH PIPE FROM THE WATER RIGHTS NOW HELD BY SELLERS.
