## Certificate of Withdrawal of Title to Land from Registry

RCW 65.12.235 Certificate of Withdrawal.

Upon the filing of such application and the payment of a fee of five dollars, the register of titles, it shall appear that the application is signed and acknowledged by all the registered owners of said land, shall issue to the [applicant] a certificate in substantially the following form:

This is to certify That David Patrick, Myers, the owner in fee simple of the following described lands situated in the county of Skamania, state of Washington, to wit:

"A track of land located in the North West quarter of the North East quarter of said Section 33, Township 2 North, Range 5 East of the Willamette Meridian, in the County of Skamania, State of Washington, Described as follows:

Beginning at the North East corner of the North West quarter of the North East quarter of said Section 33; thence West along the North line of said subdivision 662 feet; thence South 500 feet to the initial point of the track hereby described; thence South 500 feet, more or less, to intersection with the centerline of County Road No. 1106 designated as the Washougal River Road; thence following the centerline of said road in a Westerly Direction to intersection with the West line of the North West quarter of the North East quarter of the said Section 33; thence North along said West line to a point 500 feet South of the North line of said Section 33; thence East 1800 feet, more or less, to the initial point;

EXCEPT right of way for the County Road No. 1106 designated as the Washougal River Road; AND EXCEPT the West 299 feet of the above described track."
