This notice is provided pursuant to the 60 day notice provisions of the Columbia River Gorge National Scenic Area Act (the Act) at 16 USC 544m(b)(3).

Skamania County, Washington and the Columbia River Gorge Commission have knowingly violated the Act by permitting a very large, 5,000 cubic yard, solid waste dump, as defined by WRC, Ch. 70.95, and the WAC, Ch. 173-304, to be established in the Spring of 1994 and to continuously exist to the present time at the southeastern intersection of Highway 14 and Sprague Landing Road in Skamania County in the Columbia River Gorge National Scenic Area.

Skamania County approved the dump by falsifying numerous public records to provide that "soil" rather than solid waste had been dumped and unlawfully prevented administrative appeal of the approval.

The Columbia River Gorge Commission had actual notice of the dump, but failed to take action pursuant to its affirmative duty under the Act to ensure County compliance with the Act.

Skamania County's falsification of public records and numerous related violations of federal, state and local laws and regulations evidence that it lacks the capacity to lawfully administer the Act.

The Columbia River Gorge Commission was created by the Act through an interstate compact. Its sole duty is to ensure lawful

administration of the Act. By intentionally failing to address this violation, it has violated its raison d'etre.

The Secretary of the United States Department of Agriculture has overall responsibility for the Columbia River Gorge National Scenic Area and, although there is no evidence that the Secretary had either actual or constructive notice of this dump, the Secretary is a necessary party to any contemplated civil action.

Sixty days from the date of the receipt of this notice a civil action shall be filed in the Federal District Court naming the Secretary, Skamania County, the Columbia River Gorge Commission and certain individual public officials as defendants. A plaintiff class shall be sought consisting of all foreign and domestic beneficiaries of the Act. The suit shall seek actual and punitive damages, injunctive relief and fees and costs of suit.
