KNOW ALL MEN BY THESE PRESENTS, that DONNA G. EXLEY and KAREN GOODE FITZSIMONS, each in her capacity as Co-Trustee of Goode Family Trust dated December 5, 1991 and amended August 3, 1995, hereinafter called Grantor, for good and sufficient consideration, hereby conveys and warrants to KAREN GOODE FITZSIMONS and EDWIN C. FITZSIMONS, wife and husband, the following described real property situated in Skamania County, State of Washington, to wit:

BEGINNING at a point on the West boundary line of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, where said boundary line intersects with the center of the channel of Washougal River; thence in an Easterly direction following the center of the channel of said Washougal River to a point six hundred (600) feet East of the West boundary line of Section 34, Township 2 North, Range 5 East of the Willamette Meridian, which last mentioned point is the Southeast corner of a tract of land conveyed by the first part herein to William J. of land conveyed by the first part herein to William J.
