TELEPHONE LINE RIGHT-OF-WAY EASEMENT

KNOW ALL MEN BY THESE PRESENTS, that the undersigned, for five hundred dollars (\$ 500.00 ) and other good and valuable consideration, the receipt whereof is hereby acknowledged, do hereby grant unto UNITED TELEPHONE COMPANY OF THE NORTHWEST, an Oregon corporation, and to its successors and assigns, the right and privilege of entry upon the lands of the undersigned situated in the County of Skamania and State of Washington more particularly described as follows:

A 20 ft. by 30 ft. easement for electronic communications equipment cabinets together with associated jumper cabinet, standby generator w/fuel tank and fenced enclosure, within Tax Lot 500, ref. prop. deed in Book 120, Page 594, SE1/4, NW1/4, Sect. 27, T-3-N, R-8-E-WM; the true point of beginning of said easement commencing at a point on the north R/W line of Berge Road, 60 ft. west of the CL of Indian Cabin Road; thence west contiguous with said north line of Berge Road 30 ft., thence 90 deg. right 20 ft., thence 90 deg. right 30 ft., thence 90 deg. right to the true point of beginning; all as shown on attached exhibit "A" which by this reference is made a part thereof.

Note: This easement encompasses and enlarges all of Telephone Line Right Of Way easement recorded in Book 83, Page 919 Auditors File 98207, and therefore supersedes said easement.

and the right to construct, reconstruct, operate and maintain on or under the above described lands and/or in, upon or under all streets, roads or highways abutting said lands, a telephone line or system, to cut and trim trees and shrubbery that may interfere with or threaten to endanger the operation and maintenance of said line or system and to license, permit or otherwise agree to the joint use occupancy of said line or system by any other person, firm or corporation for telephone, television or electrification purposes.

The undersigned agree that all facilities, including all telephone equipment, installed on the above-described premises at the grantee's expense shall remain the property of the grantee, removable at the option of the grantee.

TO HAVE AND TO HOLD unto UNITED TELEPHONE COMPANY OF THE NORTHWEST, an Oregon corporation, its successors and assigns, the easement rights hereby granted.

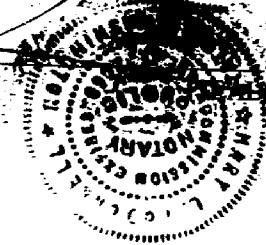

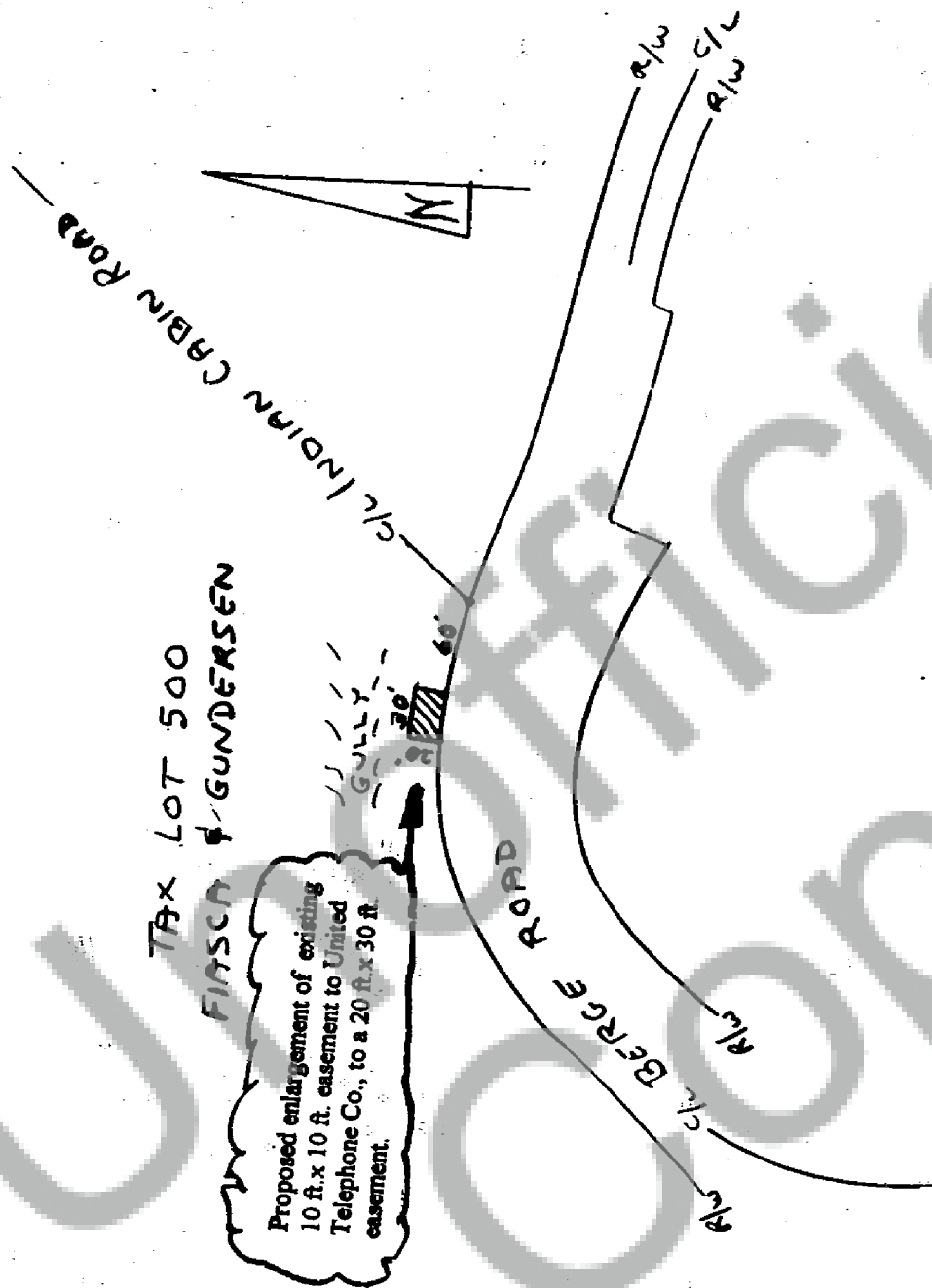
