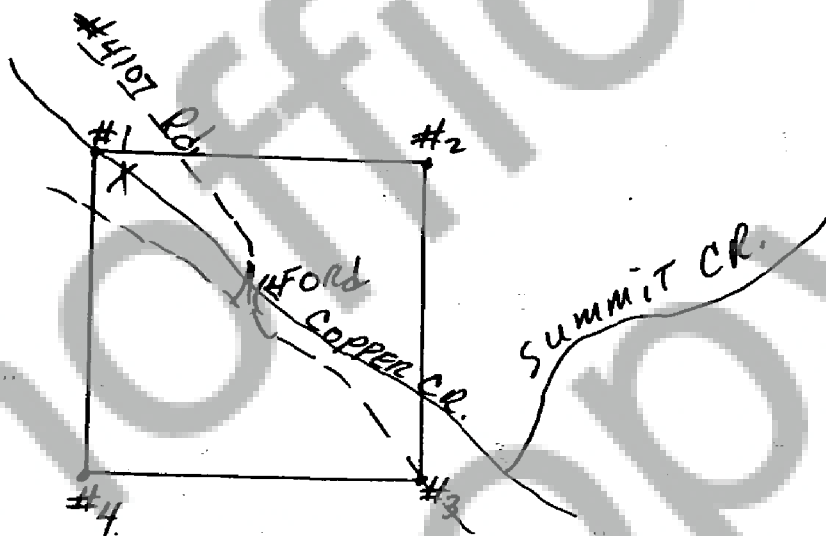
Notice of Location of Placer Claim

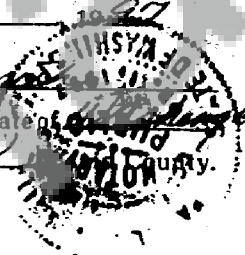
