**ACTION AS A RESULT OF VACATION PROCEEDINGS
and PUBLIC HEARING of JULY 1, 1996**

WHEREAS, Resolution No. 1996-30, approved on June 10, 1996, did declare the intent to vacate certain rights-of-way and did direct the County Engineer to report on the road as required by Chapter 36.87.040 R.C.W., and

WHEREAS, the Board did receive the Engineer's Report on said vacation and did call for a public hearing on this matter to be held on Monday, July 1, 1996 and

WHEREAS, Notices of Public Hearing were published and posted as required by Chapter 36.87.050, R.C.W., and

WHEREAS, on July 1, 1996 a public hearing was held and testimony from the public was received, considered and recorded, and

WHEREAS, the former Board of County Commissioners determined that the public would be benefited by the vacation of that certain right-of-way and took action to vacate and improve said road and to designate a portion as primitive; and

WHEREAS, the previous Board of County Commissioners did not formalize their July 1, 1996 action by signing a written resolution; and

WHEREAS, the present Board of County Commissioners has reviewed the information and testimony received regarding this matter and has determined the former Board's actions were in the best interest of Skamania County; now

BE IT RESOLVED that the present Board of County Commissioners of Skamania County, Washington does hereby ratify and reaffirms the previous Board's action of July 1, 1996; now

THEREFORE BE IT FINALLY RESOLVED AND ORDERED BY THIS BOARD OF COUNTY COMMISSIONERS OF SKAMANIA COUNTY WASHINGTON, in accordance with R.C.W. 36.87.060, that **CAPE HORN ROAD No. 10050** (lying within Sections 10 and 16 of Township 1, Range 5 E.W.M.) be:

- 1) Be vacated at Mile Post 1.31 to Mile Post 1.61 (end) and
- 2) Skamania County will improve the existing cul-de-sac at Mile Post 1.31 in it's existing footprint, and
- 3) That portion of CAPE HORN ROAD (No. 10050) lying between Mile Posts 1.05 and 1.31 be designated as a Primitive Road.

Pursuant to action of July 1, 1996, this resolution is hereby approved and signed this 21st day of April, 1997.
