- 1. That the City of Stevenson has easements for ingress, egress and utilities over the following described properties, for the benefit of the City's tax lot 400 described in Exhibit A attached hereto and incorporated herein:
  - (a) The southeasterly 25 feet of Lots 1 and 2 of the Hartman Short Plat as shown on the map thereof recorded in Book T at Page 45 of Short Plats, records of Skamania County, Washington (formerly known as the southeasterly 25 feet of Tract 1 of the Anthony Pappas Short Plat recorded in Book T at page 24 of Short Plats, records of Skamania County, Washington);
